EUROPEAN UNION OF THE DEAF YOUTH (EUDY)

The European Union of the Deaf Youth is a European non-profit organisation whose membership comprises of the Youth National Associations of the Deaf and Youth Sections of National Associations of Deaf people in Europe. Established in 1987, EUDY is the only organisation representing the interests of Deaf Young Europeans in Europe. Currently, EUDY has 28 Full members, from Iceland to Romania, and from Spain to Finland. EUDY strives to foster the personal development of young deaf persons with a sign language in Europe and to further mutual understanding to advance and protect the rights of and opportunities for young deaf Europeans.

SACDY is engaged in various activities of deaf children and young people, developing education, support and deals with the deaf community, deaf solves the problems in their lives and removes communication barriers. Part of the work is also organizing lectures in the field of deaf community – World Youth, and also participates in various international activities of deaf people at home and abroad. The main objective of our organization is to maintain a culture of deaf education and raising the level of ordinary people. Represents, protects the rights and interests of deaf youth in Slovakia.

PARTICIPANTS

Participants must be between 13 and 17 years old, following the birth year. This means a 13-year-old person may participate in the Junior Camp if they are turning 12 in the year of the camp. A person who will be turning 18 years old during the year of the camp will not be allowed to participate.

LEADERS

Leaders must be between 21 and 30 years old, following the birth year. Leaders should be fluent in International Sign and have previous experience working at camps and/or working with children.

THEME AND LOGO



EXPLANATION OF THEME:

The EUDY Junior Camp 2018 theme is "IDENTITY OF THE DEAF".


The aim of this camp is to unleash to juniors to have higher self-esteem, to realize they are able to do and to know overcome their identity. The campers will build their knowledge during camp exchanging different cultures and traditions within the Deaf Community, analysing their behaviors, traditions, cultures and norms. Then they will bring to home their gratifying experiences and knowledges such as International Sign Language, new friends, and it will enhance solidarity towards others. Awareness and respect of our essential identity understanding of how to integrate each other in different countries.

EXPLANATION OF LOGO:

The EUDY Junior Camp 2018 Logo reflects the theme and location of the camp. According to the logo, the place of the camp is represented by the well-known Slovak symbol: the symbol of Tatra is the territory of Slovakia which will be at camp and ornament on the camp, it is as a cultural symbol of the Slavs, which is there in the ground at the heart of Slavic culture. Even juniors show gender equality. Over two juniors are surrounded by EU stars.


LOCATION

Recreation Center Tesáre 95621 Tesáre district Topolčany Slovakia



The EUDY Junior Camp 2018 will take place from 21 - 29 July 2018 at Tesáre, Slovakia. Our extensive recreational complex is located in the south-eastern part of Považský Inovec near the vineyards of the village Tesáre. The building is surrounded by greenery of floodplain forests and the river Chotina, which flows into the Tesárska water dam known for its unique mineral spring Vajcovka. Water from this strand helps in digestion and digestive difficulties and has a comparable quality to the well-known Piešťany springs.

Tesáre Recreation Center is 17 km from Topoľčian, 7 km from the Duchonka recreation area, 2 km from the village Tesáre and 120 km from Bratislava Airport. Its 3 hectares are among the largest resorts in Slovakia. Ideal location and equipment is suitable for sports events, nature schools, children's summer camps as well as short-term family stays.

VACCINATIONS

For Slovakia, there are no required vaccinations. However, it is encouraged to stay current on routine shots e.g. (MMR and DPT vaccinations, poliovirus vaccine, Hepatitis A & B, etc.)

ALCOHOL AND DRUG POLICY

Consumption of alcohol and drugs is absolutely prohibited for the entire duration of the camp. Any participant under the age of 18 is NOT permitted to smoke. Also if you have permission from your parents, you cannot smoke. Medicine prescribed by the doctor is allowed if you bring a doctor's note with an explanation. Parental permission is required for bringing or buying over-the-counter medicine.

HEALTH INSURANCE \sim MEDICAL FORM

Each participant is expected to provide some kind of health coverage for the duration of the camp. Participants will be asked to explain about their medical needs on the registration form.

Campers have the freedom not to reveal anything about their medical needs, but EUDY and the Organising Committee will not be responsible in any way should something happen.

TRAVEL INFORMATION

Please read the travel information below carefully.

ARRIVAL on 21 July: We have arranged a bus to drive us from the Bratislava Airport (airport code: BTS) to Tesáre. The bus will leave at 16:30h UTC+1, so it is very important that your flight arrives before 15:30h UTC+1.

DEPARTURE on 29 July: A bus will take us back from Tesáre to the Bratislava Airport. We will arrive by 11:30h UTC+1, so please make sure to schedule your flight back home after 13:00h UTC+1.

Bus / Train this is an easy connection with public transport directly:

- 2. Bratislava Train Station Bratislava Airport (Bratislava Letisko)

To remember you have to come in Bratislava Airport before 16:30h UTC+1. It is possible to change the time of departure and arrival according to the participants and the situation.
